## Regulation RoHS-II – 2011/65/EU and RoHS-III – 2015/863

Dear customer,

RoHS-II regulation did become effective by January, 2<sup>nd</sup> 2013.

RoHS-III regulation will become effective by July, 22<sup>nd</sup> 2019.

The main differences between RoHS, RoHS-II and RoHS-III regulations are:

- 1) The scope of the directive was enlarged.
- 2) CE-compliance-declaration must include the RoHS-II regulation.
  - 1) The substance-bans, declared by RoHS-II and RoHS-III, have been regarded by all Distec-products since the regulation has taken effect. Therefore the enlarged scope of the RoHS-II and RoHS-III regulation are irrelevant to Distec and no action must be taken.
  - 2) Distec has adapted the CE-compliance-declarations of all end products when the RoHS-II-regulation and RoHS-III –regulation came into effect and provides them for customer use.

Distec GmbH hereby confirms that, according to current knowledge, all products sold by Distec GmbH comply with the 2011/65/EU regulation and 2015/863 regulation.
